



Artistico - Linea (Grainy Metallic Texture)

Water based grainy textured, glossy and decorative finishing interior surface paint. .

Areas of Use

Can be applied on all previously painted surfaces that are prepared, interior surfaces of concrete, plaster, black cast, betopan, glass textile and wall paper.

Specifications

Concentration: 1,25 ± 0,02 (gr/cm³)

Application

The application surfaces must be smooth, durable, humidity-free and self-accommodating. The coatings on previously painted, glass textile, or wall paper covered surfaces must be removed, if possible, and a smooth and even surface must be obtained by applying **Bianca Interior Wall Paste**. After the paste applied surface is sanded, **Bianca Vals Water Based Satin Primer** must be applied to complete the surface preparation process. Due to its weak and chalking quality, sateen plaster should never be used in preparing the surface. **Bianca Artistico Linea** is applied on the surface without dilution and by means of a decorative brush creating horizontal, vertical or diagonal patterns as desired. When the product is about to dry, the liquid on grainy texture of the product is removed by applying slight pressure with a clean and thick brush. This will ensure that the grainy texture achieves an opaque appearance while the background remains glossy. After the application is completed the tools must be cleaned immediately with water. Prior to use the paint must be thoroughly mixed until it becomes homogeneous. Do not apply the product at temperatures lower than +5°C. Prior to an application on glossy and glassy surfaces, the surface must be sanded to establish a solid base to achieve better adhesion. .

Thinning (Volume)

The product is ready for use. It does not require dilution.

Drying Period (at 20°C, %65 HR)

Dryness to the Touch: 30 minutes

Complete Dryness: 24 hours

Waiting time between layers: 4 - 6 hours.

Coverage

Depending on the application and the surface, for single layer, 1 litre will be enough to cover the 5 - 7 m². To determine definite consumption amount; controlled sample test must be conducted.

Storage

The product can be stored for 2 years in its unopened package, in a cool place, and protected against direct sunlight and frost.
